#### **POLICY STATEMENT**

This policy is intended as an institutional admissions policy for all colleges at Augusta University (AU). The Office of Academic Admissions processes applicant materials for all applicants except those to the Medical College of Georgia and the Dental College of Georgia, which each has their own admissions departments within their respective colleges.

#### **PROCESS & PROCEDURES**

Initial applicants to Augusta University are considered for admission if they meet all published minimum entrance requirements established by the University and the program to which they apply. Applicants not meeting these requirements may be considered on a case-by-case basis by the appropriate program and/or college. Judgment of eligibility is based on the completed application, transcripts, test scores, and other applicable qualifying factors. Minimum admissions requirements can be found in the Augusta University catalog and on the Office of Academic Admissions website. The University website includes links to online applications and admissions policies for undergraduate and graduate/first professional degree programs.

Individual colleges develop college and program specific admissions policies, and all admissions policies are based on the accepted standards of the accrediting body for the given program, where relevant. Faculty representatives in colleges requiring program-specific admissions make recommendations to the appropriate dean for those programs. All admission applications are regularly evaluated and updated.

For transfer applicants, the criteria used in admitting students vary as a function of the particular program to which the student is applying and whether the student seeks admission to an undergraduate non-health science, or selective health sciences, or graduate program.

Augusta University admission's policies are consistent with all University System of Georgia Board of Regents policies and procedures.
